



Billing and Reimbursement has information necessary for claim submission, including billing tips, provider-specific procedure code

databases (including fee screens), electronic billing information, Sanctioned Provider list, Beneficiary Co-Payment Requirements, Third Party Liability, etc.



Communications and Training gives access to Provider Update newsletters, numbered letters, information on training opportunities, etc.



Prior Authorization gives access to the Medicaid Nursing Facility Level of Care Determination tool.



Waivers includes information related to current and proposed Medicaid waivers.

Approved Medicaid Policy Since October, 2015

- ▶ MSA 15–51 and MSA 15–52 MI Child Transition to MIChild Medicaid Expansion Program
- ▶ Optimistic that Medicaid Coverage of Lactation Support Services to be distributed via list-serve in March.

IRS Form 1095-B

- ▶ Sent to Medicaid, HMP, and MIChild beneficiaries.
- ▶ Those who lost their form can log-on to the myHealthPortal application at www.michigan.gov/myhealthportal to reprint their tax form.
- ▶ Beneficiary Help Line at 1-800-642-3195 (TTY 1-866-501-5656).

Updates

- ▶ Effective October 1, 2016, MIHP services for all Medicaid Health Plan enrolled beneficiaries will be administered by the Medicaid Health Plans.
