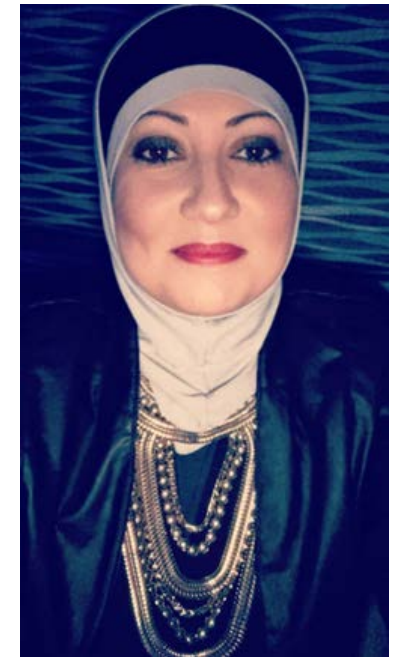

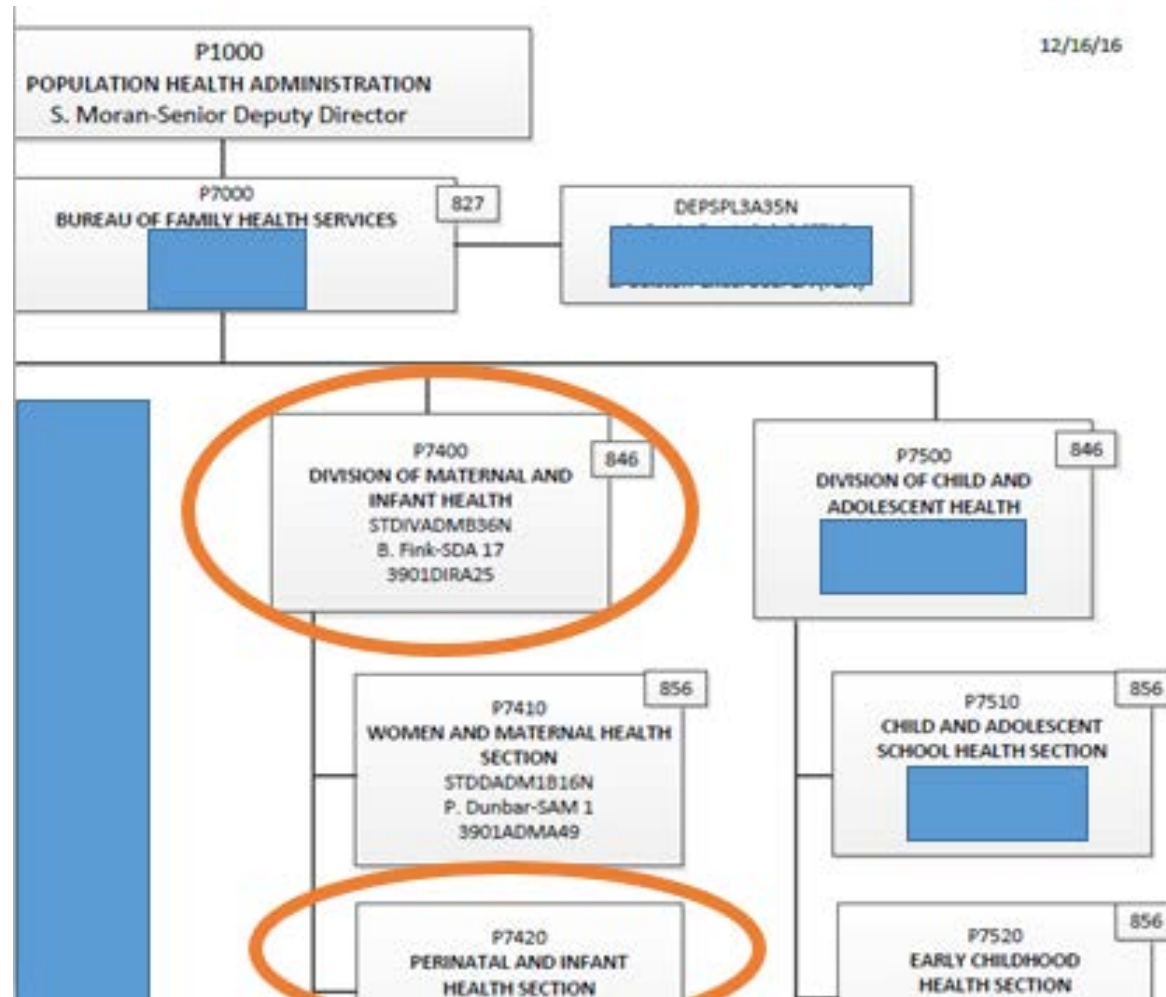

# MIHP/ MHP Transition

## Changes in Benefit Administration of MIHP Services for Individuals Enrolled in Medicaid Health Plans (MSA 16-33)

As of January 1, 2017 MIHP services provided to individuals enrolled in a Medicaid Health Plan (MHP) are now administered by the MHP. As a result of this change, all MIHP services provided to MHP enrollees are coordinated and reimbursed by the MHPs. MIHPs will need to contract with individual health plans to receive payment for services.

# MIHP UPDATES

## MIHP Operations Guide

- The ***MIHP Operations Guide Summary of Revisions*** effective Jan 1, 2017 is posted on the MIHP Website.
- This 4-page summary notes each significant change that has been made and gives the *Op Guide* page number where it is discussed.





# MIHP UPDATES

## Optional MIHP Forms

- The only optional form: ***MIHP Referral Follow-Up Worksheet***.
  - You also have the option of using the ***MIHP Contact Log*** or a similar form of your own design, but you must use a contact log.
- If a form is optional, it is stated in the ***MIHP Operations Guide*** and forms instructions.







# MIHP UPDATES

## Two New Forms for Multiple Births

### ASQ 3 & ASQ-SE 2 for Multiples (MIHP 520 Form)

- Required if you have Twins, Triplets, etc.
- Tracks ASQ-3 and ASQ:SE-2 Completion
- Placed in Billable Infant's Chart
- Copies may be made and placed in the Non-Billable Infant's Chart





# MIHP UPDATES

## Two New Forms for Multiple Births

### Progress Note Not Billed (MIHP 2001 Form)

PVPN for Beneficiary whose Medicaid ID is not used to bill Blended Visits

- To Document numbered Interventions provided for any beneficiaries in the family who have an “open” risk identifier
- Blended visits
- Required if interventions are provided
- Use other visit information section of PVPN to record activity other than interventions
- Do not document these interventions on POC2 and Discharge Summary at this time
- Goes in billable beneficiary chart
- May be copied and included in non billed beneficiary chart





# MIHP UPDATES

## Procedure for Documenting Phone Contacts

- Phone Referrals given to Clients must be Initially Documented on the Contact Log
- At the Next PVPN Visit, Document the Previous Phone Referral from the Contact List on the PVPN in the Referral Section
- All Referrals must be Noted on the Discharge Summary







# MIHP UPDATES

## MIHP “Referral” Definition

Continuous Quality Improvement (CQI) Project of Michigan’s Home Visiting Initiative

- Plan-Do-Study-Act (PDSA) cycle
- Began as a way to define Maternal Depression Screening Referral for HV

A referral is considered to have occurred when program staff have identified a need and provided appropriate information to the client for additional services outside of the home visitation program.





# MIHP UPDATES

## MIHP “Referral” - Recommended Steps

1. Discuss the particular resource(s) with the client, so he/she clearly knows what to expect
2. Encourage the client to seek services from the resource(s)
3. Determine whether the client wants to seek services from the resource(s)
4. Provide specific information in writing about contacting the resource(s) due to limited English proficiency
5. Determine if the client needs assistance
6. Provide assistance in contacting the resource(s) as needed
7. If the client doesn't wish to receive services, ask about his/her reasons and, if appropriate, gently encourage him or her to think about it, explaining the potential benefits. Ensure that you revisit the referral at the next appropriate juncture. Some referrals may need to be revisited sooner than later
8. Document that a referral was made even if the client didn't accept the referral or take action
9. Ensure that the appropriate release of information forms have been signed

## Technical Difficulties with MIHP Application

The state IT Team continues to work diligently to identify and resolve technical difficulties MIHP providers are experiencing with the MIHP application





# MIHP UPDATES

## IT Updates

### Domain/Risk Score for Infant Safety

- IT is aware that the domain/risk “Infant Safety” may have an initial score of “high;” however, intermittently the discharge summary will indicate there was “no risk” for infant safety. IT continues to work on a solution, contact your consultant if you encounter this issue.

### Missing Medicaid Number

- IT is aware that some risk identifiers that initially had a Medicaid number are now missing the Medicaid number. This will prevent the provider from being able to locate or complete the discharge summary. IT continues to work on a solution, contact your consultant if you encounter this issue.

### Duplicate Demographic

- When entering a risk identifier, some providers have received a prompt “duplicate demographic exists”, IT continues to work on a solution, contact your consultant if you encounter this issue.



# MIHP UPDATES

## To Access MIHP Agency Data Reports From CHAMPS

- Login to MILogin and click on the CHAMPS application link. Acknowledge Terms & Conditions
- Select your CHAMPS user Profile (to view data reports you must have a CHAMPS profile with “Full Access”). “View only” access users cannot view data reports. Click Go.
- Once at the main CHAMPS screen click My Inbox . Click Archived Documents.
- Once at the Archived Documents screen select a Document Type from the drop-down list. Click Go.
- Narrow your results by selecting an item from the Filter By drop-down list. Enter criteria in the field(s). For date selections enter From and To date in a MM/DD/YYYY format. Click Go to see your search results. Columns with up and down arrows allow you to sort ascending or descending.
- To view a specific document from your search results, double-click on the Document Name. The document or a File Download window will appear. Click Open or Save for File Download.

- MIHP Authorization for Services
  - See the Procedure for Prior Approval on the MIHP Website
- Training Certificates – Must be Provided as Requested for Certification Review
  - After October 1, 2016 ALL Training Certificates will be on the MPHI Portal
  - Certificates for Training Prior to this Date, Contact Your Consultant
- Transportation – Certification Criteria #54B
  - As of January 1, 2017 Charts with a Risk in the Transportation Domain do NOT Need to Name the Actual Transportation Provider - Transportation Interventions Continue to Apply





# MIHP Quality Improvement

## CYCLE 6 Certification Reminders

### Provider Notification

- Entry into Program – Documentation sent to BOTH Beneficiary's Health Plan and Medical Care Provider
- Entry Into Program if No Health Plan – Documentation Sent to Medical Care Provider and then to Health Plan when Health Plan is Chosen
- Significant Change – Documentation Only Sent to Medical Provider
- Discharge from Program Discharge from Program – The only Documentation will be the Notice of Discharge Letter sent to BOTH Health Plan and Physician Office without D/C Summary







# MIHP Quality Improvement

## CYCLE 6 Certification Reminders

### Indicator #56 – Discharge Summary

- Discharge Summaries do NOT Need to be sent to the Health Plan or the Provider – You are Only Required to Send the Letter
- To Improve Accuracy in Completion of Discharge Summaries
  - Discharge Summaries may Only be Completed Online
  - Discharge Summary Worksheets are no Longer Available





# MIHP Quality Improvement

## CYCLE 6 Certification Reminders

### Care Coordination and Chart Audits

- Agencies are Required to utilize a Standard Form, Checklist or other Tool to Document Program (Care Coordination) and Billing Chart Reviews. The Certification Chart Review Tool located on the MIHP Website may be used for this purpose.
- There is no MIHP Program Requirement for the number or percent of Records an MIHP agency is audited.

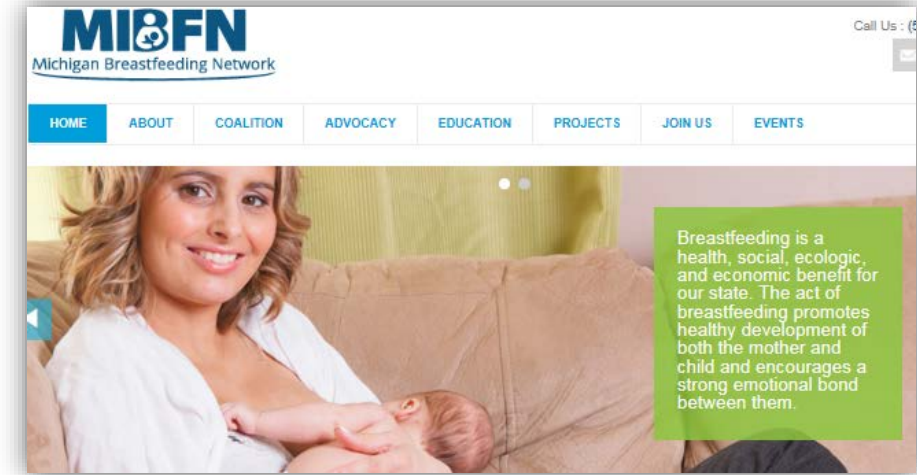
### Mission Statement



## Help Dads to Support Moms and Breastfeeding



### THIS SECTION INCLUDES TIPS ON:

1. Teaching Dad about the benefits of breastfeeding.
2. Addressing Dad's concerns related to his partner breastfeeding.
3. Encouraging Dad to support Mom during pregnancy.
4. Supporting Dad to support Mom after pregnancy and while breastfeeding.


#### Did You Know?

Research tells us that support from her partner is an important factor in a woman's decision to breastfeed her baby! Since their support is so important, Dads (or Dads-to-be) should be educated on the benefits of breastfeeding.

#### 1. Educate Dads about the Many Benefits of Breastfeeding

Dad may not have heard the many reasons to breastfeed. WIC staff can teach Dad about the benefits to his baby. You may want to talk about some of the following benefits:

- Breastfeeding stimulates brain growth. Mom's milk helps the baby's IQ reach full potential.
- It may mean fewer doctor visits. Mom's milk lowers the baby's risk of allergies, asthma and infections.
- Breastfeeding is less expensive than formula.
- It helps Mom stay calm and bond with the baby. The hormones produced while nursing help Mom relax.
- Breastfeeding helps Mom to lose the baby weight.
- It protects Mom against excessive bleeding after delivery, delays the return of her period, and lowers her risk of cancer.



"Getting started breastfeeding and keeping it up for the first year of the baby's life - as the American Academy of Pediatrics recommends - is so much easier when the new mother and father act as a team, encouraging each other and helping each other to be supportive, involved parents, nursing experts agree. First-time parents, especially, need to remember that they need to work together to learn how to become good parents...A new mother is just as scared as the father is of doing the wrong thing. Confidence comes with spending time with the baby ... and with practice."
