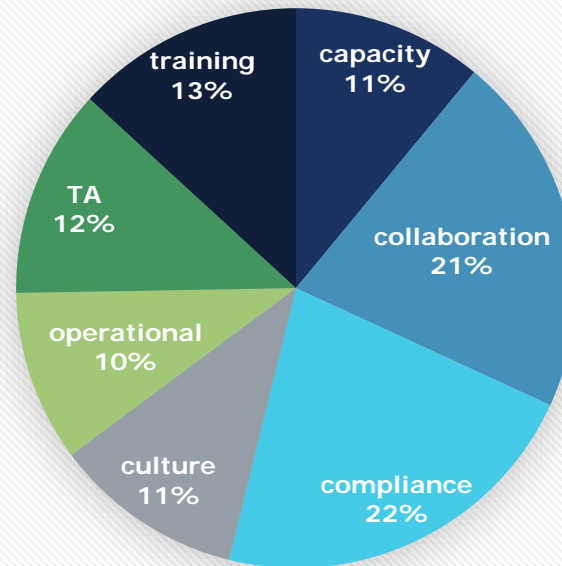
Coding Summary

- **Data was Coded**

 - **Capacity** (staff, workload, finances...)
 - **Compliance** (RMTS, monitoring, codes, qualified staff...)
 - **Collaboration** (region/state, state/local, finance, communication...)
 - **Culture** (attitude, support...)
 - **Operational** (systems, CHAMPS, Illuminate...)
 - **TA** (technical assistance)(website, newsletters, tip sheets...)
 - **Training** (trainers, trainees, material...)

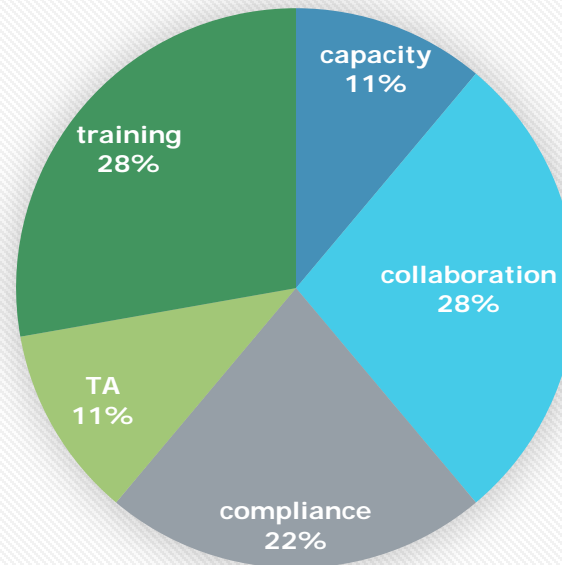

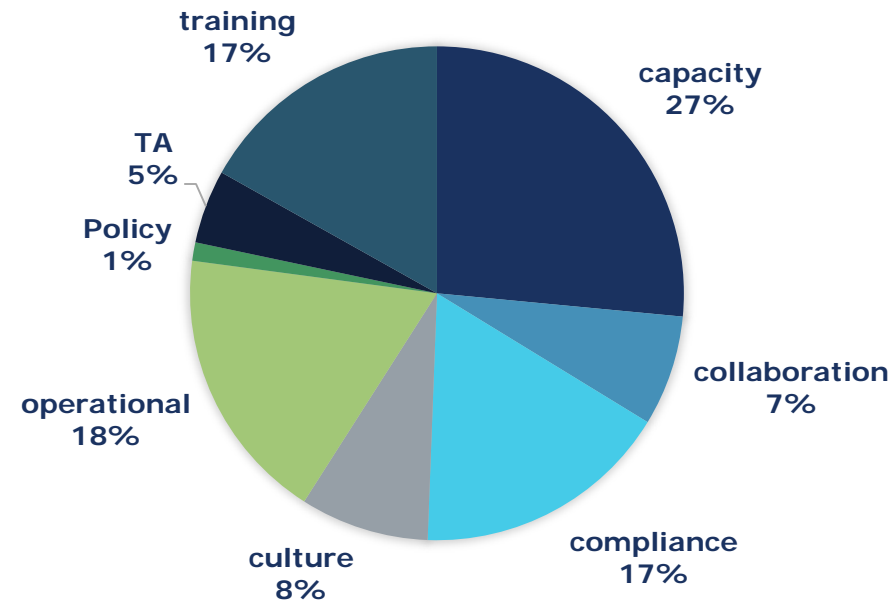

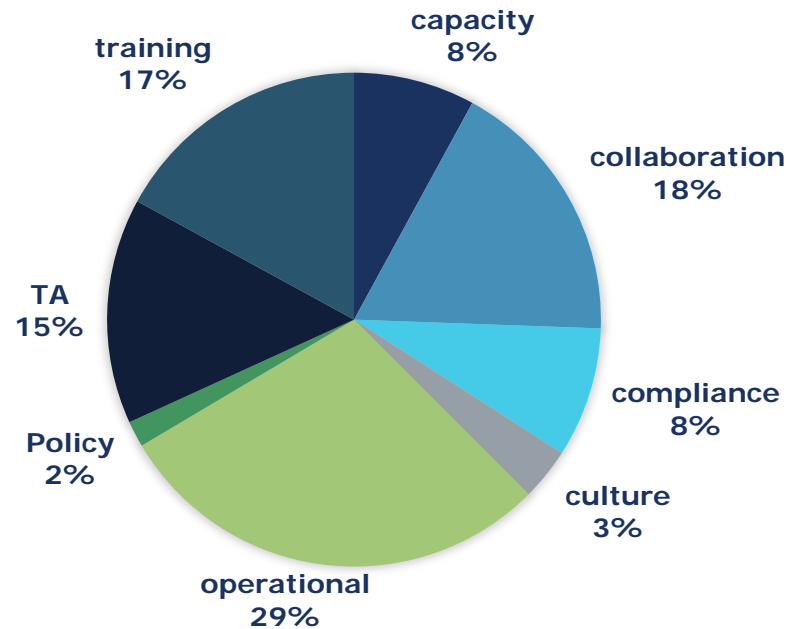

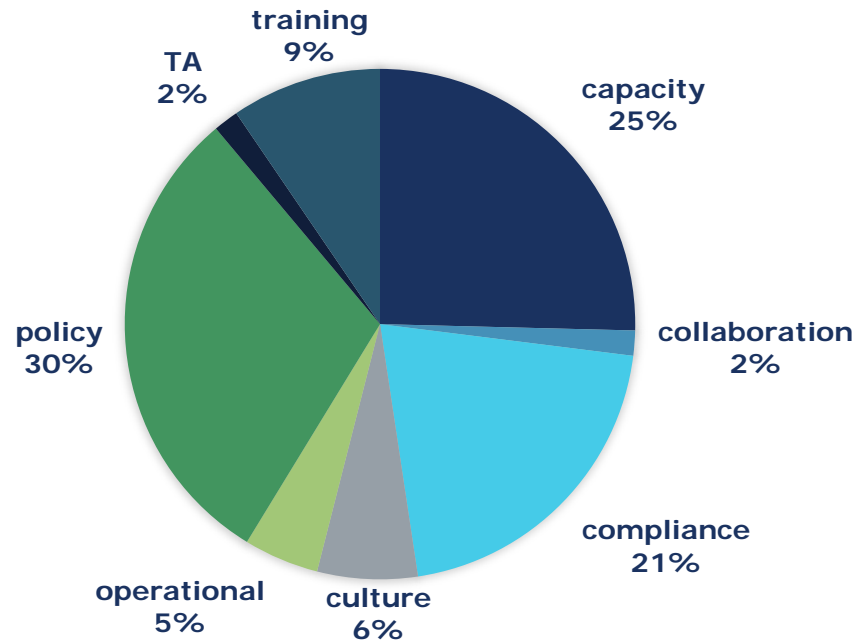

Statewide SWOT Identified THREATS

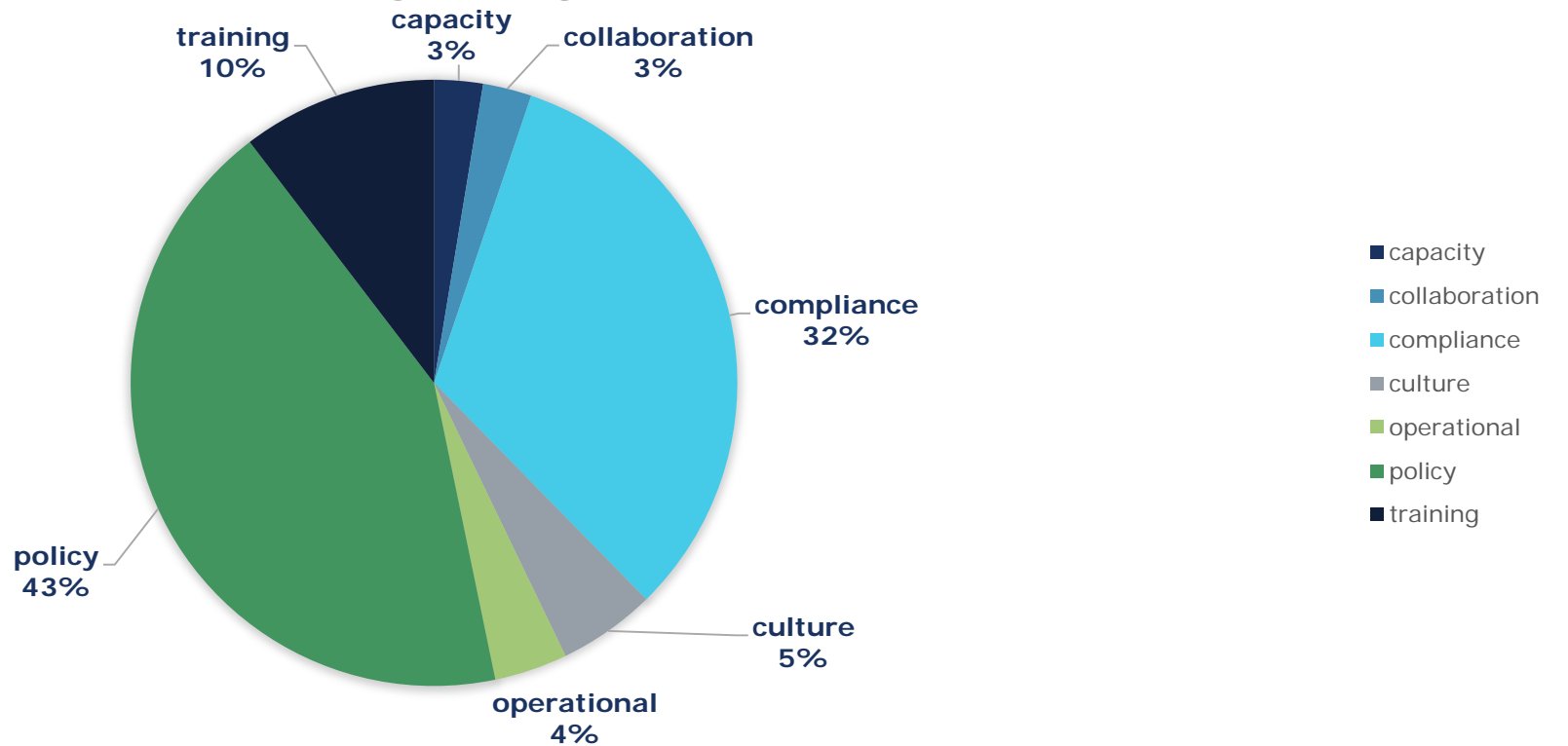

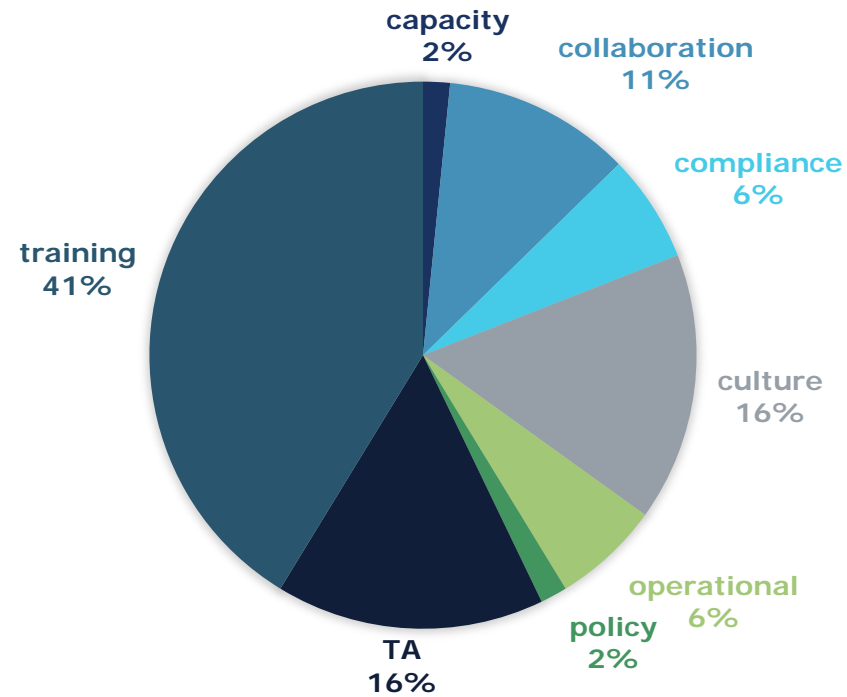
Statewide SWOT Identified Threats PRIORITIES

STATEWIDE SWOT IDENTIFIED THREATS PRIORITIES



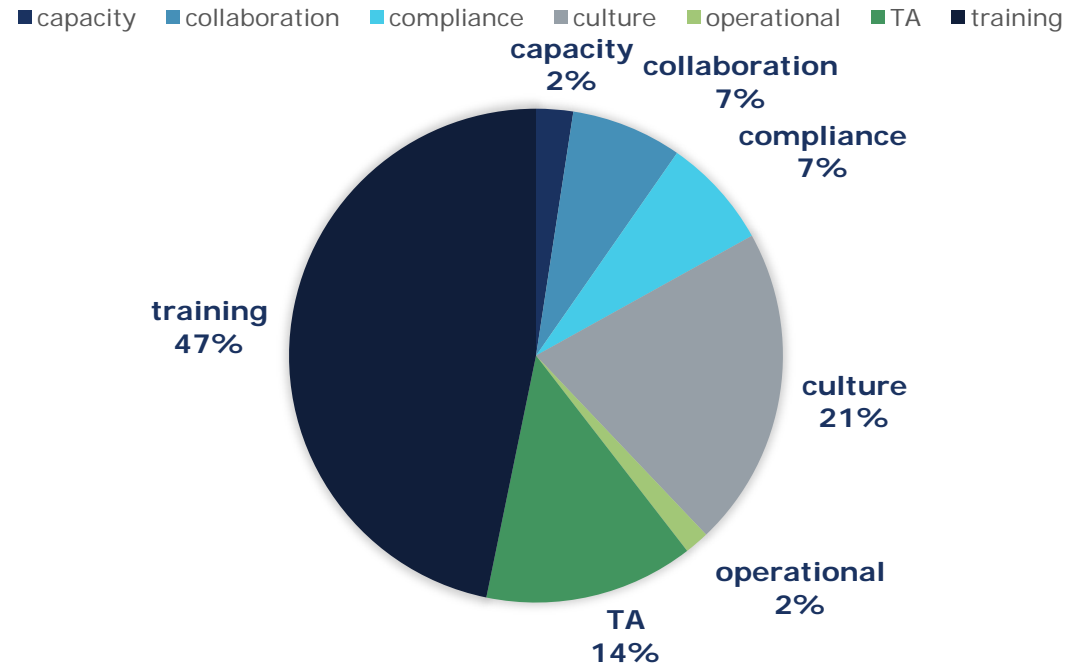
